SUBMISSION OF THE SOUTHWATER NEIGHBOURHOOD PLAN

On behalf of Southwater Parish Council, the Submission Southwater Neighbourhood Development Plan (SNP) and its supporting evidence is submitted to Horsham District Council under Regulation 15 of The Neighbourhood Planning (General) Regulations 2012 (as amended).

In accordance with Regulation 15 this submission includes:
